GOR Announces Determination of Matters Regarding Cancellation of Own Investment Units

2 March 2018 – Global One Real Estate Investment Corp. (“GOR”) announces it resolved the matters regarding the cancellation of all acquired own investment units based on the provisions of Article 80, paragraph 2 and 4 of the Act on Investment Trusts and Investment Corporations at a meeting of its Board of Directors held today.

1. Total number of own investment units to be cancelled : 2,479 units
(1.1% of total number of investment units issued and outstanding before cancellation)
2. Scheduled cancellation date : 16 March 2018
